


**DESCRIPTION OF PROPERTY TO BE SEARCHED**

The premises located at **6005 Sunset Gardens Rd, Albuquerque, NM 87121**, and the curtilage thereof, including the single family residence and all outbuildings and vehicles located on the property. The premises located at 6005 Sunset Gardens Rd, Albuquerque, New Mexico 87121 consists of a single story single family home. The house is light tan in color with a kaki colored gable roof with asphalt type tiles. The residence has a carport and driveway on the east side of the residence. There is a tree and a bush on the west side of the house that faces the street and rock gravel from the curb to the house. There is a white mailbox on a metal tube post at the curb just to the left of the driveway. The residence is marked 6005 in black numbers on a white background on a post just left of the center of the carport facing the street.

**ATTACHMENT "B"**

**DESCRIPTION OF PROPERTY TO BE SEARCHED FOR AND SEIZED**

Items and records to be seized include all evidence, fruits and instrumentalities, in whatever form (including on a computer or other storage medium) pertaining to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506, including:

1. USPS Express Mail Parcel # EA120629433HK containing 61 counterfeit Sports Jerseys and 40 Counterfeit Baseball caps.  
45 Jerseys with Reebok and NFL logos.  
15 Jerseys with Adidas and NBA logos.  
40 baseball caps with MLB logos/holograms.

2. Any Counterfeit trademarked items such as Clothing, apparel, hats, holograms, hangtags or trademark symbols relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506.

3. Any and all records relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506; including shipping packaging and/or packaging slips, business records and other documents relating to the importation, purchase, sale and/or transfer of property in the form of written documents and records, both on paper and in computer systems or other electronic devices at the location where the smuggled commodities are to be delivered, stored, or sold.

4. Any and all records relating to occupancy and/or property ownership, including utility bills, rental/lease agreements, property deeds, proof of occupancy documents.

5. Any and all business transaction records, customer lists, financial statements, and other evidence of financial transactions relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506, including shipping packaging and/or packaging slips, business records and other documents relating to the importation, purchase, sale and/or transfer of property in the form of written documents and records, both on paper and in computer systems or other electronic devices at the location where the smuggled commodities are to be delivered, stored, or sold.

6. Any and all telephone and address books, communication devices and/or records, mobile and cellular telephones, including records of telephone calls whether recorded in writing or electronically, and lists of telephone and pager numbers or papers which reflect names, addresses and/or telephone numbers of individuals relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506.

7. Books, records, ledgers, receipts, notes, bank records, credit card records, photographs, DVD's and/or other papers relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506.

8. Records or documents that show the expenditure of funds for personal and business-related expenses such as receipts, invoices, check stubs, check registers, ledgers, statements of account, payroll records relating to violations of Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506.

9. Electronic devices which are capable of analyzing, creating, displaying, converting, or transmitting electronic or magnetic computer impulses or data. These devices include computers, computer components, computer peripherals, word processing equipment, modems, monitors, printers, plotters, encryption circuit boards, optical scanners, external hard drives, external media, personal digital devices and other computer-related electronic devices that were or may have been used as a means to commit violations relating to Title 18 United States Code §545, Title 18 United States Code § 2320, Title 18 United States Code § 2319 and Title 17, United States Code §506.

10. Computers, computer hard drives, or other physical objects upon which computer data can be recorded (hereinafter, "COMPUTER") that is called for by this warrant, or that might contain things otherwise called for by this warrant as described in paragraphs 3,5,7,8 and 9 of this attachment, including:

- a) Evidence of who used, owned, or controlled the COMPUTER at the time the things described in this warrant were created, edited, or deleted, such as logs, registry entries, configuration files, saved usernames and passwords, documents, browsing history, user profiles, email, email contacts, "chat," instant messaging logs, photographs, and correspondence.
- b) Evidence of software that would allow others to control the COMPUTER, such as viruses, Trojan horses, and other forms of malicious software, as well as evidence of the presence or absence of security software designed to detect malicious software.
- c) Evidence of the lack of such malicious software;
- d) Evidence of the attachment to the COMPUTER of other storage devices or similar containers for electronic evidence.
- e) Evidence of counter-forensic programs (and associated data) that are designed to eliminate data from the COMPUTER.
- f) Evidence of the times the COMPUTER was used.
- g) Passwords, encryption keys, and other access devices that may be necessary to access the COMPUTER.

- h) Documentation and manuals that may be necessary to access the COMPUTER or to conduct a forensic examination of the COMPUTER.
- i) Contextual information necessary to understand the evidence described in this attachment.
- j) Records and things evidencing the internet protocol address relating to violations of Title 18 United States Code §§545 and 2319 and Title 17, United States Code §506.
- k) Routers, modems, and network equipment used to connect computers to the internet.
- l) Records of internet protocol addresses used.
- m) Records of internet activity, including firewall logs, caches, browser history and cookies, "bookmarked" or "favorite" web pages, search terms that the user entered into any internet search engine, and records of user-typed web addresses.

11. As used above, the terms "records" and "information" include all of the foregoing items of evidence in whatever form and by whatever means they may have been created or stored, including any form of computer or electronic storage (such as hard disks or other media that can store data); any handmade form (such as writing, drawing, painting); any mechanical form (such as printing or typing); and any photographic form (such as microfilm, microfiche, prints, slides, negatives, videotapes, motion pictures, or photocopies).
